I have received the file for Herman J. F. Bottcher from the Federal Archive Center. I can now reply fully to your January 13, 1986 letter requesting information regarding Mr. Bottcher on behalf of Mark A. Smith.

An application for National Service Life Insurance that Captain Bottcher signed on October 21, 1943 shows his birthplace to be Landeberg, Germany. He states that his date of birth was July 13, 1909.

A beneficiary of Mr. Bottcher's insurance is still being paid. We are not permitted to reveal this person's identity or address. However I have taken the liberty of forwarding Mr. Smith's letter and a copy of my reply to your office to the beneficiary. The beneficiary may then decide whether to provide information and assistance to Mr. Smith.

I hope this provides you the information that you need to answer Mr. Smith's inquiry.

Any information the VA could provide to us on Bottcher's place of birth, date of birth, former addresses of survivors would greatly assist us in preparing our article on Bottcher.
